Developers Break Ground on *Walgreens*

Dear Neighbor:

After countless delays, site preparation has begun for the new Walgreens at 111th and Kedzie Avenue. Currently, the City of Chicago Department of Water Management, Commonwealth Edison, Peoples Energy, AT&T and Comcast are all relocating their various utility lines to accommodate the new construction. A formal groundbreaking was held on Thursday, May 13, 2010 and developers hope for a spring 2011 completion.

As many residents know, this project has been a long time coming. Developers originally came to me with a plan to demolish and rebuild the Walgreens at its current site. Given the significance of this corner, I encouraged them to expand the project to include a Mt. Greenwood signature plaza, new parking lot, and additional commercial space that would give new life to the area.

With input from neighbors and community groups, we put together a design for the new project that added character and aesthetic appeal to this major commercial intersection. During that time, developers purchased two buildings on Kedzie Avenue from the Mt. Greenwood Local Redevelopment Corporation in order to assemble necessary parcels of land. Other acquisitions included streets and alleys, as well as two pri-

vate homes. Finally, after much planning and negotiating, we arrived at a redevelopment agreement a few years ago.

Unfortunately, many of the agreements in this redevelopment package were based on real estate market land value. When the market declined, a host of new complications and delays were born. Ultimately, all the previously agreed upon land values had to be re-



gotiated and appraisals repeated; circumstances also forced the developer to seek financial assistance from the City.

Economic turmoil also jeopardized bank financing of this project; however, I pushed forward each day, trying to facilitate the redevelopment

ment of this land in the manner that was promised to the community. By working with various city agencies and departments, the developers finalized a TIF subsidy that would allow the project to move forward. However, doing so required constant oversight and various levels of legal and government approval.

Now, after numerous designs and plans, we are very pleased to announce the long anticipated groundbreaking. As I have for the past several years, I will continue to monitor this project through the

construction and eventual grand opening of this exciting new commercial area. The ongoing patience of the immediate neighbors and the entire Mt. Greenwood community is greatly appreciated.

Wishbone Comes to 95th Street

Popular West Loop restaurant "Wishbone" has entered into an agreement with the City of Chicago to renovate and occupy the former Beverly Branch Library at 2105-25 W. 95th Street. The well-known Chicago restaurant is famous for its



southern reconstruction menu that includes delicious breakfast offerings as well as lunch and dinner entrées. The new Beverly location will feature BYOB liquor service.


Wishbone will acquire the former library, including two buildings and a private parking lot which will accommodate 25 cars. Rehabilitating the property is expected to cost \$1.1 million dollars and generate 50 temporary construction jobs. Construction is slated to begin later this year, with high hopes for a January 2011 completion date. Annual property taxes are expected to be \$35,000, with a projected \$250,000 in annual sales taxes.

Once renovation is complete, the main library building will serve as a 170-seat sit-down restaurant with a standalone private dining room. The Wishbone project is expected to

create 50 new permanent jobs and hopes to be one of the first LEEDS certified restaurants in the City of Chicago.

Restaurant owner/chef Joel Nickson met with immediate neighbors and civic leaders before seeking the formal approval of Chicago's Community Development Council (CDC). "Neighbors and other business owners are very excited to have Wishbone on 95th Street", said Lois Weber, Executive Director of the 95th Street Business Association. "Joel Nickson and his family are making a serious investment in our community," added Weber.

Wishbone's other locations in-

clude restaurants in the West Loop, North Side and suburban Berwyn. The restaurant has become famous for its southern infused brunch menu and trademark artwork.





Park District Acquires Land at 106th & Western Ave.

On February 12, 1998, Chicago Firefighter/Paramedic Patrick King and Firefighter Anthony Lockhart lost their lives fighting a 4 alarm fire at Beverly Tire & Auto Center at

10611 S. Western Ave. Since then, Alderman Ginger Rugai has persevered, with a vision to preserve the sight of that tragic fire as a memorial to these two brave men. After a

string of owners, bankruptcies and court appearances, the Chicago Park District acquired the land this April.

Alderman Rugai has assembled a committee of active and retired firefighters and CFD officers, artists, civic and business associations and landscape architects to pursue a concept for the memorial. "The vision is for a passive green space that pays tribute to King and Lockhart, a rebirth for this piece of land that has sat barren for so many years" said Rugai.

Several landscape architects and artists submitted their individual ideas to develop the park. The committee, after evaluating each submission, is working to form a composite that includes popular elements from the all of the designs. The final idea will include a central art feature with smaller artistic displays throughout the property. Firefighters on sight the night of the fire have marked the spot where the two

men were found. A special tribute is being planned for that site.



The committee hopes to have a design finalized by early summer. With the final design in hand, the group will pursue funding. "We are hoping to construct the memorial using a mix of public and private funds," said Rugai.

"I am honored to serve on the committee to create and develop this park dedicated to the memory and sacrifice of Firefighters Anthony Lockhart and Patrick King. These gentlemen represent the true meaning of selfless service to others without regard to their own personal safety. This park will serve as a much-deserved tribute to their memories. It is my hope also, that as this parcel of green landscape grows and matures, it will become a place of peace, celebration and rebirth for those whose lives were touched by the tragedy, as well as all others that visit," said Maryrose McNamee of the Gold Badge Society.

Blackwelder Park Construction Update

After input from community members, the Chicago Park District has finalized a design for a new playground at Blackwelder Park, 11500 S. Homewood Avenue. Through this project, the Park District will demolish the existing playground located at the far south end of the property and rebuild a new playground at the northern edge of the park adjacent to 115th Street. The new park will include soft surface throughout the play area, new equipment, a water play feature, upgraded lighting and wrought iron fencing around the entire property. The new location, combined with the upgraded lighting will increase visibility in the new park.

Demolition is expected this August with construction completing in November 2010. This project is funded by Alderman Ginger Rugai with cooperation from 34th Ward Alderman Carrie Austin.

Clean & Green a Huge Success

On Saturday, April 17, 2010 Alderman Ginger Rugai and the Department of Streets and Sanitation sponsored the annual “Clean & Green” in conjunction with Earth Day at various locations throughout the Beverly Hills, Morgan Park and Mount Greenwood community. This year, several civic organizations participated in the program beautifying the parks and other public spaces throughout the area.

Park. Through the tremendous effort of those involved in this project, the park, playground, flower beds and surrounding areas were thoroughly cleaned and all of the trees were mulched. Among those groups in attendance were: the football team from St. Xavier University and Coach Mike Feminis, the members of Crosswinds Church and Pastor Steven Puett, students from the Chicago High School for Agricultural Sciences along with coordinator Mr. Christopher Harris, the Cub Scouts, Brownie Troops 21621 and 20700 from St. Christina Elementary School, Brownie Troop 2631 from Cassell Elementary School, and a group from Mother McAuley High School. 
BAPA Hosts Spring and Summer Special Events

This year's Grand Marshal is neighborhood resident Mike McAlinden, a former Marine Corps Captain who served in Iraq and Afghanistan.

The **8th Annual Beverly Hills Cycling Classic** returns to Beverly/Morgan Park on Fri., July 9. More than 125 professional and elite amateur cyclists are expected to participate in the race, the first leg of the 17-day Interna-

tional Cycling Classic Superweek Pro Tour. The Classic starts and finishes at 107th and Longwood Drive. The race begins at 6 p.m. and riders will cycle 100K – about 60 miles – in approximately two thrilling hours. The circuit runs on Longwood Drive, Seeley and Hoyne, 105th Place and 108th Place.

The International Cycling Classic is a world-class cycling event attracting top riders from the U.S. and many foreign countries. The local event includes a festival on the grounds of Beacon Therapeutic School, featuring music, food, beverages and more.

Music Under the Stars, the annual outdoor family concert, will be held Sun., Aug. 1 on the grounds of Morgan Park Academy, 2153 W. 111th St. Gates open at 6 p.m. and the event begins with free dance lessons, followed by live music. Beverages and picnic foods are available for purchase, and chairs can be rented. The evening culminates with a spectacular fireworks finale.

The **2nd Annual History Mystery Bike Tour** will be held on Sun., Oct. 3, starting at Kennedy Park, 11320 S. Western Avenue. This event showcases the history and fun of the community, inviting families to hop on their bikes and pedal down neighborhood streets tracking down clues that will help them solve the History Mystery.



Business with History of Problems Loses License

Blue Island's Bread & Bottle No Longer Able to Sell Liquor

For the past few years, residents throughout of Morgan Park and Blue Island have been plagued by problems the Bread & Bottle Liquor Store at 2227- 2229 W. 119th Street in neighboring Blue Island. Over the years, neighbors have reported problems with loitering, sale of al-

cohol to minors, and property damage on adjacent blocks.

Despite a good working relationship with Blue Island, the Chicago Police Department has had few legal options in dealing with this problem business. Sale of alcohol to minors at this location was the subject of a Blue Island Liquor Commission hearing on Thursday, April 29, 2010.

Both Alderman Ginger Rugai and Committeeman Matt O'Shea were present at this hearing voicing

the negative impact Bread & Bottle has had on the Morgan Park community. Several neighbors from the Chicago side of the street submitted a petition calling for the revocation of the store's liquor license. After nearly three hours of testimony, Mayor Peloquin concluded the hearing.

Five days later, the City of Blue Island announced the revocation of Bread & Bottle's liquor license. The store will still be able to sell packaged groceries; but with the absence

of liquor, a huge change has already been observed by the neighbors. "The level of quiet was immediately noticed by everyone in the vicinity," commented one neighbor who helped organize the petition.

"Bread & Bottle has created problems for neighbors in Morgan Park as well as Blue Island for many years. We are extremely grateful to Mayor Peloquin for taking this step towards improving both of our communities," said Alderman Rugai.

Many of us in the Chicagoland area were stunned to learn about the vicious attack on two women in the Bucktown neighborhood. These young women were walking home one night when they were brutally beaten with a baseball bat. Both women suffered serious injuries. Natasha McShane, a 23 year old from Ireland, remains in critical condition. Through the efforts of the Chicago Police Department, two suspects were brought into custody and have been charged with aggravated battery and armed robbery. Natasha came to Chicago in January, and is currently a graduate student at the University of Illinois Chicago. The oldest of five children, she is an intelligent and outgoing young woman who has made many friends during her short time in Chicago.


Since the attack, Natasha has undergone a series of dangerous surgeries and medical procedures. Her parents flew immediately to Chicago, fearing the worst possible news for their eldest child. Unfortunately Natasha's recovery will be a long and difficult process and her parents are facing skyrocketing medical expenses.

New Program Provides Jobs for Unemployed

Last month, Governor Pat Quinn unveiled the "Put Illinois to Work" (PIW) program, an anti-poverty initiative aimed at building a healthy workforce by putting unemployed and under-employed Illinois residents back to work. The new program is expected to create more than 15,000 jobs.

"Put Illinois to Work will provide well-paying jobs that will help support families and strengthen communities," said Governor Quinn. "The program will also assist in building a workforce that possesses the skills, abilities and experiences that Illinois employers need to remain competitive in the U.S. and global marketplace."

Put Illinois to Work is a collaborative effort of the Illinois Department of Human Services (IDHS), the Illinois Department of Commerce and Economic Opportunity (DCEO), and Heartland Human Care Services (HHCS). Funding is provided through the Temporary Assistance for Needy Families (TANF) Emergency Contingency Fund (ECF), which was created by the American Recovery and Reinvestment Act of 2009 (ARRA).


This program allows eligible Il-

linois residents to be placed in subsidized employment positions with participating worksites, for up to six months, where they will learn valuable skills and be able to support their families. The program will help stimulate Illinois' ailing economy and develop a healthy workforce by providing a meaningful work experience for participants.

Private, public and non-profit businesses are encouraged to sign on with Put Illinois to Work. Eligible participants will be matched to subsidized employment opportunities at these worksites in hopes that they might transition into unsubsidized positions at the program's conclusion.

Eligible worksites and participants must meet program criteria and agree to adhere to specific programmatic requirements. Participants must be at least 18 years of age with a household income below 200 % of the Federal Poverty Level (\$2,428 per month for a family of two) and be legally present and authorized to work.

No Soliciting Signs Available Now

In response to community complaints, Alderman Ginger Rugai worked with former Alderman Manny Flores to draft and pass a citywide ordinance prohibits marketing or advertising materials from being delivered to homes that clearly display a "no-soliciting" or "no-trespassing" sign. "There were complaints about litter and potential crimes of opportunity" said Rugai, whose office will distribute the flyers through community meetings and online.

Those businesses that choose to advertise door-to-door are now required to display all of their contact information clearly on any promotional materials. Furthermore, they

are required to instruct all delivery staff to avoid homes with either a no trespassing or no soliciting sign clearly displayed.

Any businesses whose materials are left behind at a home displaying such a sign are subject to fines and other penalties. A sample no soliciting sign is printed in this paper and can be downloaded at www.the19thward.com; printed signs are also available at Alderman Rugai's Offices, 10400 S. Western Ave. and 3017 W. 111th Street. Alderman Rugai encourages all homeowners to display these signs and contact 3-1-1 to report any violations.

CHIPRA helps to keep kids healthy

More than 250,000 children in Illinois do not have health insurance! This means parents have to think twice before bringing a child to the doctor with an earache, sore throat, or playground injury. Often this means they do not get regular health care and sometimes end up in the Emergency Room with a far more serious illness that if they had received health care sooner. More than half of these children come from working and middle class families who earn too much to qualify for state programs like Medicaid, but not enough to afford private health insurance. Illinois All Kids Program is the answer for these families. This is Illinois's no to low cost health insurance, administered by the Illinois Department of Healthcare and Family Services (HFS). All Kids insures every child regardless of medical conditions, immigration status or income.

Many families are discouraged from applying for this program because of lack of transportation to get to an HFS Office, lack of knowledge or understanding of the program, worries that applying for this coverage might affect their immigration status, or concern that they do not have the proper documents.

A new program available through Beacon Therapeutic can assist these families. Beacon Therapeutic is a social service agency that has a wide array of services to benefit



children and families in the Chicago land area. Beacon's newest program, CHIPRA (Children's Health Insurance Program Reauthorization Grant), is an outreach program funded through a federal grant targeted at improving healthcare for children and families across America. The Beacon CHIPRA Team has all the necessary materials to inform and assist families through the process of applying for Illinois's All Kids. Beacon staff will meet with families in community centers, churches, schools or homes to share information about the program, assist with applications and do an electronic submission of the application which helps with the tracking and speed of application approval. Beacon also assists families in connecting with a health care resource once they have been approved for the program. Beacon brings the office to the family to make the process easier! Beacon is helping to keep kids and families healthy through access to regular, quality healthcare. 

Area High Schools Shift to Year Round Schedule

After working with the Chicago Board of Education, teachers and parents, both the Chicago High School for Agricultural Sciences and Morgan Park High School will operate on the Track E schedule for the 2010-2011 school year.

Under the new schedule, students at both schools will return to class on Monday, August 9, 2010, nearly four weeks earlier than in prior years. Students and faculty then have a two week break in the fall, as well as an extra week off during the traditional winter and spring breaks. Many teachers in Track E schedules also assign school work during the fall, winter and spring breaks so that students may continue learning.

While the number of school days remains the same, the students will hopefully retain more knowledge during an abbreviated summer break.

"Every elementary school teacher I know who is on the Track E schedule loves it. The breaks spread out over the school year give students and teachers opportunities to step back more often, which translates into happier students and teachers. A big advantage of Track E scheduling for high school students is that those students taking Advanced Placement classes will have a head start on preparing for the AP tests given in the spring of each year. An August start date means AP students will now have as much preparation time as students in suburban and private schools," said Peggy Goddard of the Morgan Park High School LSC.

Last year, three of Morgan Park's feeder elementary schools made the shift to Track E, so many parents of incoming freshmen will have already adjusted to the schedule shift.



Talk to Your Teens About Alcohol Today

Dear Parents:

Graduation season and the summer months are quickly approaching. These are important and memorable events in your child's life, which unfortunately, can include the use of alcohol and drugs by many teens. I encourage you to talk to your child about enjoying these milestones in a safe and responsible manner. These conversations can save lives.

Both teens and parents need to be aware that Illinois has some very strict laws regarding drinking under the age of 21. Some important facts to consider:

- According to the National Highway Traffic Safety Administration, traffic accidents are the leading cause of death for teenagers in our country.
- Illinois has a zero tolerance policy for underage drinking and driving. Teens caught driving with any amount of alcohol in their system will lose driving privileges for a minimum of three months. If someone under 21 is convicted of a DUI, meaning their blood alcohol is .08 or higher, they will lose their license for a minimum of two years.
- It is illegal to purchase alcohol for or supply alcohol to anyone under the age of 21.
- A parent/guardian who knowingly allows any persons under 21 to drink in their home or on their property, including a vacation home, is guilty of a misdemeanor punishable with fines and possible imprisonment. Should bodily harm happen to any-

one as a result of this drinking, that parent/guardian is then guilty of a felony with increased fines and longer jail terms possible.




- In addition to the criminal charges, any adult who willingly supplies alcohol to a minor causing impairment is liable in civil court for any death or injuries to people or property caused by the impaired person. There is no maximum amount to damages that can be claimed.

I have witnessed firsthand the devastation that can occur when teenager's using alcohol or drugs. I hope that together, we can make this summer a fun, memorable and SAFE experience for everyone.

Street Sweeping Season Begins



Street sweeping season officially began on Thursday, April 1, 2010 and will continue until November 19, 2010. Each street in our community should be swept a minimum of 3 times each year.

Bright orange "no parking" street sweeping signs will be posted on residential streets 24 hours prior to a sweeping. Tickets are issued for any cars that remain on the street during scheduled street sweeping. Please an eye out for the orange signs and remind your neighbors to move their cars on street sweeping days. Refrain from raking leaves or other debris into the streets and pick up any litter along the curb rather than leaving it for the street sweepers. Our street sweepers are slowed down by large volumes of leaves or litter. The more cooperation we have from community resi-

dents, the more frequently we can sweep your street.

Street sweeping days are also ideal times to notice abandoned vehicles. If you believe a vehicle has been abandoned on your street, please contact the ward office at (773) 238-8767 immediately so we may begin the steps to have it removed. The police and the Department of Streets and Sanitation watch for these vehicles, but there is no better source of information than the people who live on the street and know an abandoned vehicle from one that may simply belong to a vacationing neighbor.

Improvements Coming to 103rd & Walden Parkway

Dear Neighbors:

For the past several months, many residents have contacted my office regarding the blighted property at 1901 W. 103rd St. (103rd & Walden Pkwy). Two years ago this building was cited for building code violations. My staff attended these hearings and attempted to work with property owner Berton Ring to bring the building into compliance. After several court appearances, and under the threat of demolition, Mr. Ring has finally addressed the major safety concerns in his renovation plans. All proper building permits have been issued and work has finally begun.

While the unsightly boards and deteriorating facade have been a problem for many months, this property, and the adjacent two store fronts (1903-1905 W. 103rd St.), have received notices of building violations since June 2008.

Problems at this location escalated in October 2009 when window glass was removed from 1901 W. 103rd Street and construction began on knee walls to support new window installation. At this point, Mr. Ring had only obtained permits for an interior build-out on behalf of a Subway Franchisee. No structural exterior plans had been submitted, and no permit application for exterior work was filed. Furthermore, Mr. Ring expressed no intention to

address the crumbling facade at the two adjacent store fronts (Dr. Marcia Blake and Calabria Imports). A stop-work order was issued and a court date was set.

In December, under threat of daily fines, Mr. Ring informed my office that architectural drawings were being produced for the renovation of the store fronts at 1901, 1903, and 1905 W. 103rd Street. At a December 23 court appearance Mr. Ring was ordered to produce exterior plans and obtain proper permits to address the structural problems with his property. At this point, the windows at Calabria Imports had almost completely deteriorated; and Mr. Ring was forced to get an emergency repair permit to secure the front windows. My staff was told at this meeting that the remaining permit applications with plans would be submitted within two weeks.

It fact, Mr. Ring did not submit new plans for another month; and the drawings he finally submitted were rejected by the Building Department for serious safety problems with both the structural and electrical plans.

In March 2010, with no sign of new drawings and several failed attempts to contact Mr. Ring, I had the building inspected for demolition. Following the inspector's ruling, I informed Mr. Ring that he would either make the necessary repairs to

his building, or the City would demolish it and place a lien for costs against the property.

The day before our case was to be heard in demolition court, proper drawings were finally submitted to the building department, and permits were issued. Now that work has begun, Mr. Ring maintains that exterior renovations will take 30 days to complete and interior renovations at least 60 days. During the next few months, I will closely monitor this timetable.

While I am always bothered by unsightly property, especially along one of our most charming commercial strips, I could not allow construction to proceed knowing that the owner was ignoring proper safety precautions.

I will continue to monitor the progress, and hope the project will reflect the character and integrity of our community. Should you have any questions or concerns about this project, please feel free to contact me at (773) 238-8766 or vrugai@cityofchicago.org.

Protect Yourself From Home Repair Scams

The snow has melted, the weather is warming, and many of us are starting to think about spring cleaning. This change of season, coupled with anticipated tax returns, prompts many to evaluate their homes for any repairs needed after the harsh winter.

The Cook County State's Attorney's Office has a Consumer Fraud Unit that you can contact at (312) 603-8700 if you think you have been the victim of a home repair scam. However, I want to remind you that you can save yourself time, money and aggravation by taking a few steps prior to signing a contract and handing money over to a contractor:

- Always get at least three quotes for any major remodeling /repair work.
- Ask questions about the repair, including time frame to complete and materials. If your questions aren't answered to your satisfaction, ask again or contact another company.
- Ask for references in the area that have had similar work done and check them out.
- Be sure that you read and un-

derstand the entire contract before signing it. Make sure any promises or guarantees made during discussions with the contractor are in the contract.


• Check the company's rating on the Better Business Bureau's website: www.bbb.org

- Read the pamphlet, "Home Repair: Know Your Consumer Rights," before hiring a contractor. All home repair contractors are required by law to provide you with this pamphlet before asking you to sign a contract over \$500.

Finally, follow your instincts. If the deal seems too good to be true, it probably is. If you feel pressured or uncomfortable with the contractor or company, contact another. This is your home, most likely your largest investment, and it should be your decision on who performs the work on it.

Maloney Protects Consumers from Unauthorized Charges

State Senator Ed Maloney is supporting a plan which will protect consumers from unfair and unauthorized charges.

Sometimes when customers buy products or services, the company will automatically enroll them in a group or club. The company then charges them for membership fees or unwanted products. Customers often are not aware of these charges until they receive their credit card bills. Maloney's legislation (House Bill 4698) requires companies to get the customer's explicit consent before enrolling them in any group or club or sending them any additional merchandise.

"I don't think companies have any business charging people for goods and services they don't want," Maloney said. "It makes it more difficult for people to keep to their budgets and it creates unnecessary hassles."

Maloney's legislation was inspired by a constituent's story. The constituent bought a product advertised on television. For months afterward he was sent products he did not want, and his credit card was charged.

"I've had experiences with these club schemes myself," Maloney said. "You buy something, and they keep charging you for months afterward."

To me, this is a common sense law. A customer should have to opt in to a club, not opt out."

Maloney's plan also empowers Attorney General Lisa Madigan to enforce the law using her consumer protection authority. The Attorney General's Office will be able to use injunctions to prevent Illinois companies from taking part in this deceptive business practice.

The legislation has passed the Illinois Senate and now returns to the Illinois House for concurrence on an amendment.



Stimler resides on the Northside of Chicago with his wife, Amber. They are members of St. Matthias-Transfiguration Parish in Lincoln


Square.

The 19th Ward continues to lead the City in Blue Cart Recycling. On average, over 20% of our garbage in the 19th Ward is recycled. Currently, the citywide average is 14%. Many homes call for a second blue cart.

Yard Waste Recycling

The Chicago Department of Streets & Sanitation recently shifted their collection of yard waste from weekly to every other week. It is now scheduled to take place during the same week that recyclables are collected.

The 19th ward produced more

yard waste than any of the combined regional recycling clusters that include all or portions of several wards. Given the inordinately large amount of yard waste that we generate, it is possible that from time to time you might see yard waste in place for an extended period of time or workers other than your regular recycling crew come by and remove the accumulated yard waste.

Please continue to use your black cart with the green sticker for yard waste. Yard Waste may also be placed in paper or plastic bags (clear or translucent - preferred), next to your black cart on your Blue Cart recycling week.
