PBC Hiring for Mt. Greenwood School Modular

This February, Alderman Matt O'Shea announced plans to construct a six classroom modular and new playground at Mt. Greenwood Elementary School. The project will temporarily ease severe overcrowding at the school and has a \$3 million budget. The Public Building Commission will be facilitating two community hiring intake sessions at Mt. Greenwood Park, 3721 W. 111th St., on June 17, 2015 10:00am-3:00pm, and June 25, 2015 3:00pm-6:00pm.

At these fairs, applications for employment to work on this project will be accepted. Construction is scheduled to begin this summer with the modular complete in time for the new school year. 8th program at the Chicago High School for Agricultural Sciences.

Chicago Police Memorial Foundation Thanks Community

Dear Friends:

Alderman Matthew O'Shea and thousands of 19th Ward residents have been hard at work in support of the Chicago Police Memorial Foundation's Get Behind the Vest initiative.

The most dangerous part of the job for Chicago police officers is gun violence. In fact, 75 percent of line-of-duty deaths have been gun-fire related. Since 1980, 40 Chicago police officers have been shot in

the line of duty and saved by their bulletproof vests. Through this campaign, we hope to help protect those who protect us by purchasing replacement bulletproof vests for Chicago police officers.

Alderman O'Shea has taken up the cause of protecting Chicago's police officers and has enlisted schools in the 19th Ward to raise funds for the campaign by holding school wide dress down days, candy sales, bake sales and other

fundraising activities. So far, over \$19,000 has been raised through student based fundraisers at many area schools with several other school based events in the works!

Alderman O'Shea also enlisted the help of the Original Pancake House and St. Christina Parish in hosting a pancake breakfast in support of the initiative on February 22nd. Over 2,000 residents arrived at St. Christina School and took part in a delicious pancake breakfast generously supplied by the Harrigan Family and the Original House of Pancakes. Attendees included Mayor Rahm Emanuel, Cook County State's Attorney Anita Alvarez and cast members of Chicago PD. Over \$10,000 was raised at the pancake breakfast and a great time was had by all.

The 19th Ward didn't stop! A Comedy Night event was held at Christ the King and the proceeds of that event were also generously donated to our Get Behind the Vest initiative. Over \$11,000 was raised during the night's festivities!

The communities of Beverly, Morgan Park and Mt. Greenwood continue to rally behind our police officers, most recently demonstrated by Tranquility Hair Salon, which opened on its day off and offered



\$25 men's haircuts, with all of the money collected during the day being donated to Get Behind the Vest. \$1,500 was raised!

Our sincere thanks goes out to Alderman O'Shea, his staff and the entire 19th Ward community for their strong support and hard work on behalf of the officers of the Chicago Police Department. With their help, over \$40,000 has been raised to date and 80 officers will receive replacement vests and be given a greater chance of returning to their families at the end of their shift.



Free Rain Barrels Available

For its first major initiative, the new 19th Ward Environmental Committee, formed recently to improve the environment throughout Beverly, Morgan Park and Mount Greenwood, is partnering with the Metropolitan Water Reclamation District of Greater Chicago (MWRD) to offer free rain barrels to residents. The City of Chicago is located in a combined sewer area, which means rain-water and sewage from homes flow through the same pipe before reaching the MWRD's wastewater treatment facility. During rain events, storm water hitting the roof flows through downspouts, which leads to the sewer system. Too much flow can result in basement backups and flooding.


Residents who agree to place rain barrels on each downspout where feasible will qualify for the complimentary barrels. Rain barrels

can be requested at www.the19thward.com.

"By disconnecting downspouts from the public drainage system, we can help minimize basement backups, combined sewer overflows, and flooding. By installing a 55 gallon rain barrel to each of your downspout(s), this water can be saved for reuse, and it may even reduce your water bill," said Metropolitan Water Reclamation District Board President Mariyana Spyropoulos.

"Residents in the 19th Ward are no strangers to flooding issues. By partnering with MWRD in this new program, we hope we to help mitigate the amount of water that ends up in our streets and basements" added Alderman O'Shea.


Rain barrels and the components needed for connection will be delivered directly to your home. Instructions for installing the barrels will be included.



Shredding Event – June 6th

Pulaski Rd., from 3:00pm – 5:00pm. Residents can bring any old or unwanted papers to the school to be shredded and later recycled by the Midway Document Destruction Mobile Shredding Truck. Shredding documents helps prevent identity theft,

recycling the paper benefits the environment by reducing the amount of waste in landfills and sparing trees.



Did you know that City of Chicago Vehicle Stickers can be purchased online at www.ChiCityClerk.com? Last year one fourth of all customers skipped the lines and obtained their stickers through the Clerk's website. This is the easiest and fastest way to receive your vehicle sticker each year.

However, if you prefer to purchase your sticker in person, Alderman Matt O'Shea and City Clerk Susana Mendoza will host sales on Thursday, June 18th from

1:00-6:00pm at Ridge Park, 9625 S. Longwood Dr., and Wednesday, July 8th from 1:00-6:00pm at the 19th Ward's Mt. Greenwood Service Office, 3215 W. 111th St. To purchase a vehicle sticker, you must bring your 2015 Chicago City

Vehicle Sticker courtesy reminder form. If your courtesy reminder is lost, please bring your State Vehicle Registration ID Card, which includes your VIN (Vehicle Identification Number).

Check, money order, Visa, Mastercard, Amex and Discover Card are accepted at Ward Sales. Please remember, we are now in the Year-

Round Vehicle Sticker era. Ward Sales this year will be limited to customers with June vehicle sticker expirations. These are vehicle stickers

with "6/15" printed on them with an expiration date of June 30. The grace period is still in effect; motorists with a June 30 expiration date have until July 15, 2015 to purchase their sticker.

Legislative Update

State Representative Fran Hurley

Over the last few weeks, state Rep. Fran Hurley and the General Assembly have passed many pieces of legislation through the House that will now be considered by the Senate.

Among these measures was Hurley's House Bill 3148, which classifies an attack against an on-duty police officer, fire fighter or emergency medical technician as a Class 4 felony, punishable by up to three years in prison. Currently, the aggravated assault of a first responder is a Class A misdemeanor. This measure brings penalties in line with those for assaults against process servers and correctional officers.

Continuing her efforts to support the many special needs indi-

viduals and their families across our state, Hurley was the chief sponsor of House Resolution 198 which designated July 2015 "Special Olympics Month" in the state of Illinois. She is also working with state Sen. Bill Cunningham to pass Senate Bill 1549 that creates an income tax check off to allow taxpayers to make contributions to the Special Olympics Illinois and Special Children's Charities Fund.

To benefit local teachers in our area and stabilize the pension fund, Hurley supported House Bill 3695 which dedicates a portion of the tax levy of Chicago Public Schools specifically for contribution to the



Chicago Teachers' Pension Fund beginning in FY 2016. This bill does not increase the overall tax rate of CPS; it simply clarifies that a percentage of the levy be directed to the Chicago Teachers' Pension Fund.

Increasing transparency in state government is essential, which is why Hurley was a chief co-sponsor of House Bill 303 providing that confidentiality clauses in severance agreements cannot be enforced. Severance agreements that involve public funding and taxpayer dollars should be transparent and open to the public and this bill ensures that taxpayer dollars are spent respon-

sibly in these situations.

The prevalence of sexual assault on college campuses and the recent investigation of over 100 institutions of higher learning indicate that current laws intended to protect victims are not working. That is why Hurley sponsored House Bill 821, creating the Preventing Sexual Violence in Higher Education Act. This legislation is critically important to protecting women and men at Illinois colleges and universities and in breaking the silence that often surrounds rape and sexual violence.

Cunningham pushes legislation to prevent "squatters" from taking over empty homes

State Senator Bill Cunningham recently passed legislation in the Illinois General Assembly aimed at preventing con artist and squatters from taking possession of homes that are subject to foreclosure proceedings in the court system. If it becomes law, Senate Bill 1487 would shield properties that are in financial distress from a new form of fraud in which individuals file bogus legal documents in an attempt to claim ownership of the home.

"This fraudulent practice is particularly damaging to our communities because it not only victimizes some homeowners, but it can victimize an entire neighborhood by enabling squatters to take over an empty house," Cunningham said. "SB 1487 will close a loophole in existing law and make it more difficult for these con artists to succeed."

Starting in 2008, the "Great

Recession" resulted in record numbers of home foreclosures throughout the country. In a four year period, mortgage foreclosures were filed in court on more than eight million homes nationwide.

Every community in Cook County, included the most affluent neighborhoods, were hit by the crisis. As banks completed foreclosure and eviction proceedings against scores of homeowners, they eventually found themselves in legal possession of thousands of empty houses in Cook County – houses they could not sell because of the poor economy.

It didn't take long for con-artist to take advantage of the situation. Reports of squatters moving into empty homes began to soar. In some cases, the squatters filed paperwork with the Cook County

Recorder of Deeds Office declaring themselves "sovereign citizens" who have the right to take possession of property abandoned after foreclosure proceedings. Their claims had no legal merit,

but it didn't stop them from moving into empty homes.

Shortly after taking office, Cook County Recorder Karen Yarbrough began implementing policies and proposing new laws designed to stop the fraudulent practices of so-called "sovereign citizens." But under current state law, her office must accept all filings of claims against properties in Cook County, leaving it to the courts to sort out the validity of the documents at a later date. To cut off wrongful claims against properties on the front end, Yarbrough joined forces with

Senator Cunningham on SB 1487, which will change the existing law and allow her office to reject claims against properties that are in foreclosure court unless a judge has approved the filing.

"It is in the best interest of the community – when all measures to prevent a foreclosure have failed – that a vacant home be put back on the market as soon as possible, so it can contribute to a better economy," Yarbrough said. "People who squat in vacant homes seek a narrow, personal benefit at the expense of the community, and activity like this causes fear and panic in neighborhoods."

"SB 1487 will enable the Recorder's Office to refuse to allow bogus documents to muddy an already cumbersome process."

The legislation is now under consideration in the Illinois House.

Gas Project Coming to North Beverly This Summer

Peoples Gas is preparing to deliver its infrastructure modernization program to upgrade the natural distribution system in North Beverly. Gas pipes in the North Beverly area are safe and reliable, but at 80-110 years old, it is time to replace them. The area identified for likely upgrades starting this summer and over the next two years, spans from 87th to 95th streets from Western Avenue to Wood Street. Customers affected this summer, have already received letters from Peoples Gas.

Most of the 19th ward will need the natural gas infrastructure upgraded over the next 15 years, with some phases in Mount Greenwood and Morgan Park already complete. Another part of the project is already underway in Beverly on west 99th Street ahead of the streetscape work planned later this summer. Work near the 99th street Metra station is due to be completed mid-May and a second stretch between Western and South Bell will be completed mid-June.

"Our infrastructure modernization plan is to deliver ongoing safe and reliable natural gas service with enhanced safety features, newer pipes, more modern pressure, and less inconvenience," said Yvette Pittman, community relations representative for Peoples Gas.

Before construction begins, Peoples Gas will set up appointments to mark where the new service and outside meter will be located and installed at the property. Their workers will need to inspect the inside and outsides of homes and businesses affected to see where the gas enters the property and where current pipes and appliances are located. Peoples Gas employees and contractors all carry proper identification, so always ask to see identification before allowing workers to enter.

"Outside meters are a critical feature of the new system design," Pittman said, "In the event of an

emergency; first responders will be able to swiftly access and shut off the gas where necessary. Other new safety features include service valves which shut off the gas when damage to the line is detected and new pipe materials which allow the company to isolate outages to a much smaller area."

When construction begins, natural gas mains which bring gas to each block will be installed either under the street, in the parkway or under the sidewalk, frequently on both sides of the street. This type of work is likely to result in parking restrictions while this part of construction is taking place.

Services, the pipes that bring natural gas to your home, will be installed under the lawn or sidewalk. In order to minimize disruption to lawns and sidewalks, Peoples Gas and their contractors will be using construction equipment that bores underground for long stretches where possible. Lawns, sidewalks and other surfaces that are disturbed during construction will be temporarily restored until the old natural gas main is retired in the area.

Once the new main and services are installed, appointments will be made to move gas meters outside to the customer agreed-upon locations. After all of the properties in an area have been hooked up to the new main, the old main will be retired from service.

"The last step of the project is restoration," said Pittman. "After all the construction is complete and the old pipes are retired, restoration crews will repair everything that was disturbed. It is important to note that restoration can only be done when the weather is warm enough for concrete to set and sod to take root, which is normally from May through November in Chicago," Pittman added.





SXU / MPHS Partnership Moves Forward

Saint Xavier University is looking forward, continuing its partnership with Morgan Park High School. The 4 key priorities of the partnership, identified spring 2014 in collaboration among SXU, MPHS, and CPS OS4 include: dual enrollment, pre-service teaching, teacher professional development in International Baccalaureate, and college transition and engagement. This partnership began with the School of Education administration and faculty and morphed to a university-wide initiative including the College of Arts and Sciences dean and faculty, the Registrar, and Student Services.

This academic year (2014-15), 10 enrollments in college level courses at SXU were taken by 6 MPHS students. Two students from SXU student taught at MPHS during the 2014-15 academic year, while staff and professors at SXU coordinated field experience tutoring hours so that SXU teacher

Timothy Herring Convicted

A Cook County jury has convicted a Chicago man for a double murder in which he gunned down an on-duty Chicago Police Officer who was investigating a burglary on Chicago's South Side as well as a retired Chicago Housing Authority police officer who had reported the crime, according to the Office of Cook County State's Attorney Anita Alvarez.

Timothy Herring, Jr., 24, was convicted of First Degree Murder and Burglary for the Nov. 26, 2010 murders of Chicago Police Evidence Technician Michael Flisk, 46, and retired Chicago Housing Authority Police Officer Stephen Peters, 44. Herring was 19 years old and on parole at the time of the double murder.

The victims were both shot in the head at close range by Herring, who lived nearby and had returned to the scene of a burglary he had committed hours

earlier to collect the proceeds. Flisk was processing the crime scene in a garage at 8140 S. Burnham where Herring had broken into Peters' garage and burglarized his vehicle.

The jury began deliberations Tuesday afternoon and returned the verdict Wednesday morning. Herring faces a mandatory natural life sentence when he is sentenced.

"We welcome this guilty verdict on behalf of the Flisk and Peters' families as well as all of the citizens of Cook County who understand and appreciate the unexpected dangers that police officers face in their daily work," said State's Attorney Alvarez.

"This was an evil and heinous crime that stole the lives of two brave men who did not deserve to have their futures cut short. We hope that this verdict brings some

measure of justice and closure for the families of Officer Michael Flisk and Stephen Peters."

According to prosecutors, Peters owned a red Mustang that was parked inside of the garage behind the home where his mother lived and he had called police to report a burglary after discovering that stereo equipment and other parts had been taken from the vehicle. Officer Flisk, who had served as a Chicago Police Officer for nearly 20 years, was on duty and in full uniform when he responded to the call in his marked squad car.



According to prosecutors, Peters was standing in the alley as Officer Flisk processed the crime scene and took photographs, including photos of a garbage can near the garage that contained some of the stereo equipment that had been stolen from the car.

While Officer Flisk and Peters were in the alley, Peters' mother heard two gun shots from her home. When Peters' mother looked out the window she saw Peters lying in the alley bleeding and immediately called 911.

As she cried out for emergency assistance in the 911 call, she heard two more gun shots and observed a male with a hood covering his head walking in the alley and pushing the garbage cans. Both men sustained two fatal gunshot wounds to the head.

State's Attorney Alvarez thanked the trial team of Assistant State's Attorneys Joseph Magats and Thomas Mahoney as well as the members of the State's Attorney's Victim Witness Unit and the Chicago Police Department for their dedicated work on the case.



Daniel O'Grady, a third grader at St. John Fisher Catholic School, recently taught a weaving workshop for residents of Smith Village, a continuing care retirement community at 2320 w. 113th Place. "Over under, over under, over under," says Daniel, guiding a thick strand of turquoise yarn through a weft of black cotton string stretched over a pot-holder size piece of cardboard.

Smith Village residents Margaret Lane and Janis McHugh seem to find 9-year-old Daniel as entertaining as the favorite school craft project he decided to share with them. "You're very confident," says Margaret, wearing a big smile. The women say they will keep their items as decorative art or coasters.

Smith Village is home to nearly 300 older adults, but for years it has welcomed younger generations as participants in the lives of its residents.

"Smith Village not only provides a close-knit, supportive community for residents, but also serves as a welcoming place for their families and friends," says Marti Jatis, executive director. "By organizing intergenerational activities that attract children and younger adults, our intention is that Smith Village residents remain young at heart and in

tune with younger generations."

On any given day, residents can be found eating a mid-day meal with relatives and friends who visit the Marketplace Café, where self-service creates a casual ambiance. After the lunch hour rush, many remain to play cards or just enjoy the afternoon.

Daniel's grandparents, Walter and Beth O'Grady, moved to Smith Village from their home in Beverly in January 2014. Since then Daniel, who insists the Marketplace burgers are "awesome," has gotten to care about so many residents. "He'll see someone drop a fork, for instance, and go get them another one," says his mother Sheila O'Grady. "He loves it here. They seem to love him too!"

In summer, Smith Village holds two family-oriented events. The annual Family Fun Day draws grandchildren and families with a variety of outdoor games, a cookout-style menu and petting zoo.

For the annual pet show, residents and their families have entered their pets—cats, dogs, rats, mice, snakes, guinea pigs, even a goat—to win prizes for doing tricks, wearing costumes or just being special.

Smith Village has fostered warm relationships with local schools. Throughout the year, Marist High School volunteers earn community service credits by escorting residents to exercise classes and physical therapy, assisting with games and activities, or just spending time with residents.

Smith Village encouraged a pen pal program between St. Cajetan kindergarteners and residents. The program yielded special friendships after the class visited their Smith Village pen pals to become better acquainted.

Annie Gainer, granddaughter of Smith Village memory support resident Charles Lavin, participated in the Verizon Innovation App Challenge as a school project. Working with sixth-grade classmates from

St. Catherine of Alexandria School in Oak Lawn, she helped develop a phone app to help Charles remember names and faces. The app won state and regional competitions, and the entire group was photographed at Smith Village by numerous media outlets.

Prior to high school prom nights, several teens visit their grandpar-

ents or residents whom they've gotten to know. Plus, residents share stories about their own prom nights and provide pointers on clothing selection and dating tips.

St. Xavier University students interview residents as part of a collective history project. Computer science majors at St. Xavier share computer expertise as miSmith interns. Nursing students and gerontology majors at Moraine Valley Community College conduct research projects and complete internships as well.

"We're more than just a retirement community," Jatis says. "We like to think of ourselves as an intergenerational hub for Beverly-Morgan Park and neighboring communities."

changing events.


