A hiring fair will be held in the coming months for anyone interested in working as a bartender, cook, server, hostess or security at either location.





### CHICAGO PATROLMEN'S FEDERAL CREDIT UNION 10339 S. Pulaski Road

Saint Xavier University recently sold their building at 10339 S. Pulaski Rd. to the Chicago Patrolmen's Federal Credit Union. The Credit Union intends to demolish the existing structure and replace it with a 7,000 square foot branch that includes a drive through and 48 parking spots. The design for this project has been finalized and a timeline is currently being created. More information will be shared when it becomes available.



# Appeal Your Property Taxes - 9/25

The Cook County Board of Review is now accepting property tax appeal applications for homeowners in our area for 2017 taxes (payable in 2018). The appeal paperwork is very simple and can result in significant savings. There is no fee involved for applicants and appealing cannot increase current assessments.

Board of Review Commissioner Larry Rogers Jr., Alderman Matt O'Shea, Senator Bill Cunningham and Representative Fran Hurley will co-host an appeal assistance night on Monday, September 25th at the Chicago High School for Agricultural Sciences, at 6:30pm. Staff from the Board of Review will be available to help residents complete appeal paperwork and address any questions or concerns. All homeowners are encouraged to attend this meeting. Please bring your tax bill or property index number to complete the paperwork. If you are not able to attend, you can also file an appeal online at <http://www.cook-countyboardofreview.com/>.



The Board of Review does not assess property, set tax rates, or collect taxes. There is no fee to file an appeal, and in most cases an attorney is not necessary. Filing an appeal with the Board of Review CANNOT result in an increase in your taxes; the appeal will either reduce your taxes or leave them at the current level. Board of Review complaint forms can be obtained at the office of Commissioner Larry Rogers, Jr. in the Cook County Building located at 118 N. Clark St., Room 601. # Free Flu Shots - 9/24


Alderman Matt O'Shea, Senator Bill Cunningham, and Representative Fran Hurley will partner with the Chicago Department of Public Health to provide free influenza immunizations on Sunday, September 24th, from 10:00am to 2:00pm at the 19th Ward Office, 10402 S. Western Ave. Flu vaccines are offered at no cost to adults of any age and children over six months old. No appointment is necessary and vaccinations are provided on a first come, first served basis.



Influenza (flu) is a contagious respiratory illness caused by the influenza virus. It can cause mild to severe illness. The most serious cases can result in hospitalization or even death in extreme cases. Senior citizens, children and those with serious health conditions are at a high risk of serious flu complications. Getting an annual flu shot is the best way to prevent the illness. # Free Oak Saplings

This Fall, Alderman Matt O'Shea and the Metropolitan Water Reclamation District are providing free oak saplings to all Chicagoans. These saplings, which are approximately six to ten inches tall, can be reserved online at [www.the19thward.com](http://www.the19thward.com), and will be available for pickup on Sunday, September 10, 2017 at the 95th Street Farmers Market (95th & Longwood Drive.) from 10:00am-12:00pm. Instructions for planting and care will also be provided.



The tree population throughout the City has been decimated by emerald ash borer infestations and extreme weather. Oak trees help provide an energy saving green canopy for our community and help absorb rainwater that might otherwise flow into our sewer system and possibly flood residential basements. A medium size oak tree can absorb up to 2,800 gallons of rainfall per year.

# CPS Begins Work at Mount Greenwood & Esmond

Earlier this year, Mayor Rahm Emanuel and Alderman Matt O'Shea announced a forty million dollar investment at Mount Greenwood and Esmond Elementary Schools. Site preparation is currently underway at both locations. Any resident interested in working on one of these jobs is invited to a community hiring fair on Monday, August 21, 2017 from 10:00am-2:00pm in the Music Demonstration Room at the Chicago High School for Agricultural Sciences, 3857 W. 111th St.

An overview of both projects, provided by the Public Building Commission of Chicago (PBC), can be found below. The PBC expects the annexes to be completed in January of 2019.

## Mount Greenwood Elementary School Annex & Renovations:

A new, two-story annex to the existing two-story school will be constructed to alleviate overcrowding. The annex will include thirteen standard classrooms, one science room, two offices, storage, bathrooms, utility rooms, an elevator and building support space. The project will also include a new parking lot, storm water management infrastructure, and a new outdoor playground. Work within the school building will include the conversion of two existing classrooms for expanded lunchroom capacity.



## Esmond Elementary School Annex & Renovations:

A new, two-story annex to the existing two-story school will replace a deteriorating stand-alone modular building. The annex will include a classroom, computer classroom, science classroom, art room with storage, library, dining room, hybrid kitchen and server, administrative office, bathrooms, building storage, an elevator and building support space. The project will also include renovated parking lots, load area, refuse enclosure, storm water management infrastructure, a new outdoor playground, community garden, and a turf field.



## New Location for Mount Greenwood Service Office

The Mount Greenwood Service Office operated by Alderman Matt O'Shea, Senator Bill Cunningham, and Representative Fran Hurley has moved to 3207 W. 111th Street, just a few doors east of our previous location.



Residents can visit this office Monday through Friday from 9:00am - 2:00pm to receive assistance with any state or city government service. The Mount Greenwood Service Office can be reached by phone at (773) 238-8776.

# Legislative Update

## Senate Bill 1 Treats Chicago Educators Fairly

Over the spring legislative session, one of the biggest topics of discussion was how to treat Chicago teachers the way we treat teachers at the 849 other school districts across the state.

Currently, state law requires Chicago to pay for their own teacher's pensions through local tax levies and then pay for downstate teacher pensions through the state income tax. This is both unfair to Chicago taxpayers and unfair to Chicago teachers due to the pension

shortfall being faced by the city.

Both Governor Rauner and Democrats have agreed that the lack of parity on the way we treat Chicago teacher's needed to be addressed. We were able to do that by passing Senate Bill 1 which primarily reforms our education funding system to ensure all students have an chance to succeed in their schools.


But we also had to address the way teacher's retirement is treated in Chicago. That is why we required that the state cover the costs of Chicago's normal costs for teacher pensions. Normal cost covers the pensions being earned by current employees in the current year.

For decades, downstate schools have not had to worry about covering the normal costs of their pen-

sions because the state said they would cover that cost for them. But the state had not provided that same benefit to teachers who worked for Chicago Public Schools.

It is unfair to ask Chicago teachers and taxpayers to not only pay for their own pension program, but then also ask them to cover a portion of downstate teacher pensions. In Senate Bill 1, we fixed that problem by saying the state would provide roughly \$221 million per year for normal pension costs of Chicago Public Schools.

Now the governor has vetoed Senate Bill 1 which is the first significant reform of how we fund schools in decades. This has not only put funding for schools in question, but also put the fair treatment of Chicago teachers in question as well.



## Hurley Backs Local Business and Consumers

State Rep. Fran Hurley, D-Chicago, is working to invest in local businesses by supporting two pieces of legislation that will require Illinois state agencies to buy domestic products when purchasing goods.

Hurley is sponsoring House Bill 138, which provides that purchasing state agencies shall promote the purchase of, and give preference to, articles, materials, and supplies that have been manufactured in Illinois specifically. If the needed product is not manufactured in Illinois, state agencies are required to purchase products made in the United States.

Hurley is also a sponsor of House Bill 137 which mandates that state agencies buy American made products when purchasing goods. Purchased goods must be made up of more than 50 percent American or Illinoisan components. Certain

restrictions are included for items such as pharmaceutical drugs or when the price or quality does not meet the standards sought.

"Shopping locally has a profound effect on local economies. Local businesses employ hard-working people throughout the community, and we should be helping these businesses create jobs," Hurley said. "This legislation allows for small and medium sized businesses to flourish by investing in our communities."

Hurley wants to ensure that tax dollars are being spent within the state as much as possible. House Bill 137 and House Bill 138 have passed out of State Government Administration committee, and are currently on third reading in the House for consideration.

"When we invest in Illinois businesses, our state's economy will improve because employers will have the opportunity to create more jobs," Hurley said. "Business owners should not be required to compete with companies outside of the country, and instead should be given the appropriate support to thrive."

### Prioritizing Consumers

In continuation of her efforts to protect consumers, Hurley is sponsoring legislation that requires cable television providers to notify customers when their promotional prices expire. "Currently, cable tele-

vision providers are not required to inform customers when their promotional contracts expire," said Hurley. "This bill will promote more transparency and awareness for consumers."

Hurley is the Chief House Sponsor of House Bill 4040, which will provide customers with notice of the expiration of promotional rates and prices set for a specified period of time. Hurley's measure will ensure that customers are aware of when their current contract is expiring, and allow the customer to find a new promotion or another carrier if they choose.

## Park Improvements Coming to 19th Ward

Alderman Matt O'Shea and the Chicago Park District are excited to announce a series of improvements coming to local parks.

The Chicago Park District (CPD), Chicago's 19th Ward and the Chicago Blackhawks have partnered to build a street hockey rink at Kennedy Park (11320 S. Western Ave.) in Chicago's West Morgan Park neighborhood. Construction will soon begin on the project that will feature a SportCourt surface, creating year-round accessibility. The rink is expected to open in fall, roughly three months before the opening of the highly anticipated, 125,000-square-foot community ice arena, located two blocks south of the United Center. The street hockey rink is funded by the Chicago Blackhawks through the National Hockey League's Industry Growth Fund (IGF) as part of an initiative to further develop youth hockey. Combined with the community ice arena, this project has the Blackhawks quickly approaching well-over \$75 million of community contributions. As part of the project, a portion of the park will be improved to accommodate the rink, which will measure 80' x 175'.

At Maggie Cosme Park, the three dated and underutilized tennis courts are being completely redone. Once complete, the courts will be same caliber as the recently

improved tennis courts at Ridge Park. This project is currently out to bid with an expected budget of approximately \$75,000. Work is expected to begin in late 2017 and we look forward to increased usage of the newly refinished courts.

Over the past year, the Chicago Park District invested \$300,000 to improve the field at 117th & Oakley Ave. The scope of work included stripping the old grass and removing unsuitable materials, installing and grading new topsoil to provide a level playing field with positive drainage, and seeding with new athletic field turf grass seed. We have also top dressed with bio solids to fertilize the new grass. The field has been fenced off to allow the new turf to become established. The fence will be removed next month to allow for fall sports programming. For permitting and scheduling information, please contact Jennifer Cronin, the supervisor at Kennedy Park, at (312) 747-6198.

The Park district will also be completely resurfacing the walking path at Mount Greenwood Park and replacing the roof at Ridge Park. Both projects are currently out to bid, the walking path is expected to be completed in 2017. No formal timeline has been announced for the roof project at Ridge Park.



## Public Art Planned for 99th & Walden Parkway



Chicago artist Davis McCarty has been selected to create a piece of public art in the 19th Ward through the City of Chicago's 50x50 Neighborhood Arts Project. McCarty's project "Quantum Me" will be installed at 99th & Walden Parkway and unveiled this October. A preliminary rendering of the piece will be on display at the 19th Ward Office; all residents are invited to view work and offer written feedback through the artist now through August 31st.

"Quantum Me" is an inspirational light bending sculpture that engages the public with iridescent colors. As the sun rises light gleams off the dichroic plexiglass casting vibrant shadows of purple, green, and amber hues across the ground at Beverly's 99th Street Metra Station. Dichromatic plexiglass is a space-age technology originally developed by NASA that has astonishing properties. The material changes color based on the location of the spectator. Participants can observe the sculpture changing color by simply walking to a new vantage point. "Quantum Me's" bright hues and kaleidoscopic effect represent the vibrant and diverse makeup of Bev-

erly's citizens. "I hope people will have a moment of joy and wonder as they pass by," says creator Davis McCarty "Life gets serious, this sculpture helps remind us of the sense of discovery and excitement we felt as children exploring the world."

There is advanced science behind the design of this sculpture. Depending on the position of the spectator each may see a different color at the same time, this represents how sub atomic particles behave. "It's a little like Schrodinger's cat, by observing matter behaving in two states simultaneously we are getting a glimpse behind the wizard's curtain into the inner workings of the universe."

# SXU School of Nursing Receives Over \$880K to Assist Underserved Communities

The Saint Xavier University School of Nursing (SON) has been awarded a grant through the Health Resources and Services Administration (HRSA) within the U.S. Department of Health and Human Services (HHS). SXU's Assistant Professor of Nursing Laura Tucco, Ph.D., secured the Advanced Nursing Education Workforce (ANEW) grant for a two-year period, which began July 1, 2017 and runs through June 30, 2019.

During the 2017-18 and 2018-19 academic semesters, the grant will cover the cost of 15 family nurse practitioner (FNP) students each year. The total of the grant is \$887,467. A project will go along with the grant, which will involve a partnership with a group of Franciscan Specialty Physicians, who provide care to underserved communities, which is consistent with the SXU Mercy mission.

"Specialty Physicians of Illinois, LLC, is pleased to partner with Saint Xavier and provide a training site for family nurse practitioner students," said Franciscan Specialty Physicians of Illinois, LLC Human Resources Manager Rai Barney. "Our advanced practice providers understand the vital role of preceptors and are eager to aid in the clinical and professional development of

our community's future nurse practitioners."

Dr. Tucco, who is leading the project, must identify, select and maintain 15 dedicated FNP students for each year, work closely with the students who report to her, and encourage the continuation of a relationship with Franciscan Specialty Physicians. The pupils who receive the award will be those with a strong commitment and passion for aiding medically underserved communities.


"Receipt of the ANEW grant provides funding to support the clinical education of family nurse practitioner (FNP) students in academic-practice partnerships with clinical facilities where students will care for the medically underserved," said Tucco. "Caring for the medically underserved is consistent with the Mercy mission of Saint Xavier University. The grant provides much needed funding to FNP students allowing them to focus on their studies and prepare for future careers as primary health care providers."

Since 2014, SXU's SON has obtained close to \$2 million in awards for FNP education. The ANEW grant is now the third consecutive program to bring necessary funding for the students.

"We are very proud and excited

to have received a two-year ANEW grant from HRSA," said SXU President Laurie M. Joyner, Ph.D. "Receipt of this highly-competitive award showcases not only the hard-working efforts of our Nursing faculty, but our dedication and commitment to academic excellence. The knowledge and experiences our FNP students will receive through these clinical partnerships will be vital to their future professional success."



# Smith Village invites young readers for book club discussion

Smith Village is home to about 275 older adults, and for many years the life plan community located at 2320 W. 113th Place has welcomed younger generations as participants in the lives of its residents.

The Smith Village Women's Book Club offers a prime example. It meets at 11 a.m. on the last Thursday of the month. Recently, the book club opted to include a couple of youngsters to discuss its July selection, *The One and Only Ivan*, a children's book by Katherine Applegate. The fictional tale was inspired by the true story of a Silverback gorilla taken from the wild and forced to live in a shopping mall for 30 years. He eventually was placed with the Atlanta Zoo.

To break the ice for the discussion, which took place in Smith Village's Independent Living library, the group asked Finn McGee, 9, a fourth grader at St. Cajetan, to read a few quiz questions for everyone to answer.

"What treat did Stella (the elephant in the story) and Ivan like to eat?" McGee asked.

After a pause, someone answered, "Yogurt covered raisins."

The next question concerned a dog in the story. "What was Bob's favorite place to sleep?" McGee asked.

"Ivan's stomach," someone answered.

McGee smiled, seeming to appreciate the response.

All the while, McGee's grandmother Pat McQuillan, also smiled with pride.

Karen Jellema, human resources director for Smith Senior Living, typically leads the book club discussions and contacts libraries to secure enough book copies in advance to allow ample time for reading each month's selection. The club's choices usually range from literature to a variety of history-inspired books including historical fiction and biographies of historical figures. "We occasionally read children's books," said Jellema. "And we thought, 'What better way discuss children's literature than to invite children to join our discussion?'"

Jellema also brought fresh-baked cookies and lemonade to the group's gathering.

When Jellema asked the group the original names for Ivan the gorilla and his sister, Maddie Genis, 11, a 5th grader from Frankfort, answered, "Ivan came from a set of twins. He was called 'Mud' because

he liked to draw on his mother's back with mud. His sister was called 'Tag' because she liked to play tag."

"You have a good memory," quipped Carol O'Neill, a retired school teacher and Smith Village resident. "That's because you're young!"

O'Neill also once participated in a book club discussion of *Wonder* by R.J. Palacio with students from St. John Fisher School.

Other questions yielded comments about man's efforts to better understand and show greater respect for fellow creatures including the Silverback gorillas and the elephants portrayed in the book. The group also viewed a brief documentary featuring the real Ivan as well as interviews with mall owners and

zoo biologists who knew him.

"Inviting children and young adults to participate in activities with Smith Village residents is a hallmark of our community," said Marti Jatis, executive director of Smith Village. "We provide a welcoming place for our residents' families and friends. We support intergenerational activities to encourage Smith Village residents to remain young at heart and be in tune with younger generations."

Smith Village has fostered warm relationships with area schools. Many students perform in holiday concerts and assemblies. High school students play beanbags with the residents' winning team. Several also earn community service credits for volunteer efforts.
