Registration Now Open For the 11th Annual Beverly Hills Turkey Trot 5k Run & Family Walk, Presented by CIBC Bank



Registration is now open for the 11th Annual Beverly Hills Turkey Trot 5K Run & Family Walk, presented by CIBC Bank, on Saturday, November 30th, beginning at 9:00am at Christ The King School. Over the last decade, the Beverly Hills Turkey Trot has become an annual Thanksgiving tradition with participants running or walking the beautiful tree-lined streets of the North Beverly neighborhood. Proceeds from this year's 5K will once again benefit the John McNicholas Pediatric Brain Tumor Foundation and the 19th Ward Youth Foundation.

Runners and walkers of all ages and levels can register now for the 5K Run/Walk, Team Registration, or the untimed Family Walk, by visiting www.the19thward.com.

- Registration fees are:
- 5K Run Individual: \$35 until race day, then \$40
 - 5K Youth Individual (age 19 or younger): \$30 until race day, then \$35
 - 5K Untimed Walk Individual: \$35 until race day, then \$40
 - 5K Untimed Family Fun Walk (limit 4 sweatshirts): \$75 until race day, then \$80
- The 5K will be chip-timed on a CARA certified 5K course, while the family walk will be untimed. Runners will be divided by age and gender according to CARA recommended guidelines, with awards given for each age group. All participants will receive a t-shirt and gift bag.

Smith Village breaks ground for modernization of rehab and skilled nursing care wing with special message for families

Smith Village broke ground last month on a \$22.3 million, three-story, 10,204-square-foot addition and modernization of its interior to provide 66 private suites and rooms as well as 12 shared-suites for rehab and skilled nursing care residents. At that event on October 17, a family member joined civic leaders in lauding Smith Village's engaging lifestyle for independent adults as well as its superior care for those needing more support.

Kevin McGee, president and CEO of Smith Senior Living which sponsors Smith Village, announced

Smith Village's plan to reduce its number of licensed beds for short-term rehab and skilled nursing care from 100 to 78 to ensure the finest care and to meet expectations of contemporary adults. McGee also noted infrastructure improvements include a new roof, all new electrical and HVAC systems, plus new windows.

Among those speaking as part of the ceremony was Cathi Carlin Hogan, whose mother lived at the Washington & Jane Smith Home, forerunner to Smith Village, and whose father, Phil Carlin, Ph.D.,

became one of the first residents to join the independent living community in the all-new Smith Village in 2008.

"Smith Village continues to be a wonderful place where seniors are given the respect they deserve and a caring place they need," said Hogan who grew up in Beverly and continues to reside here. "And when that need becomes greater,

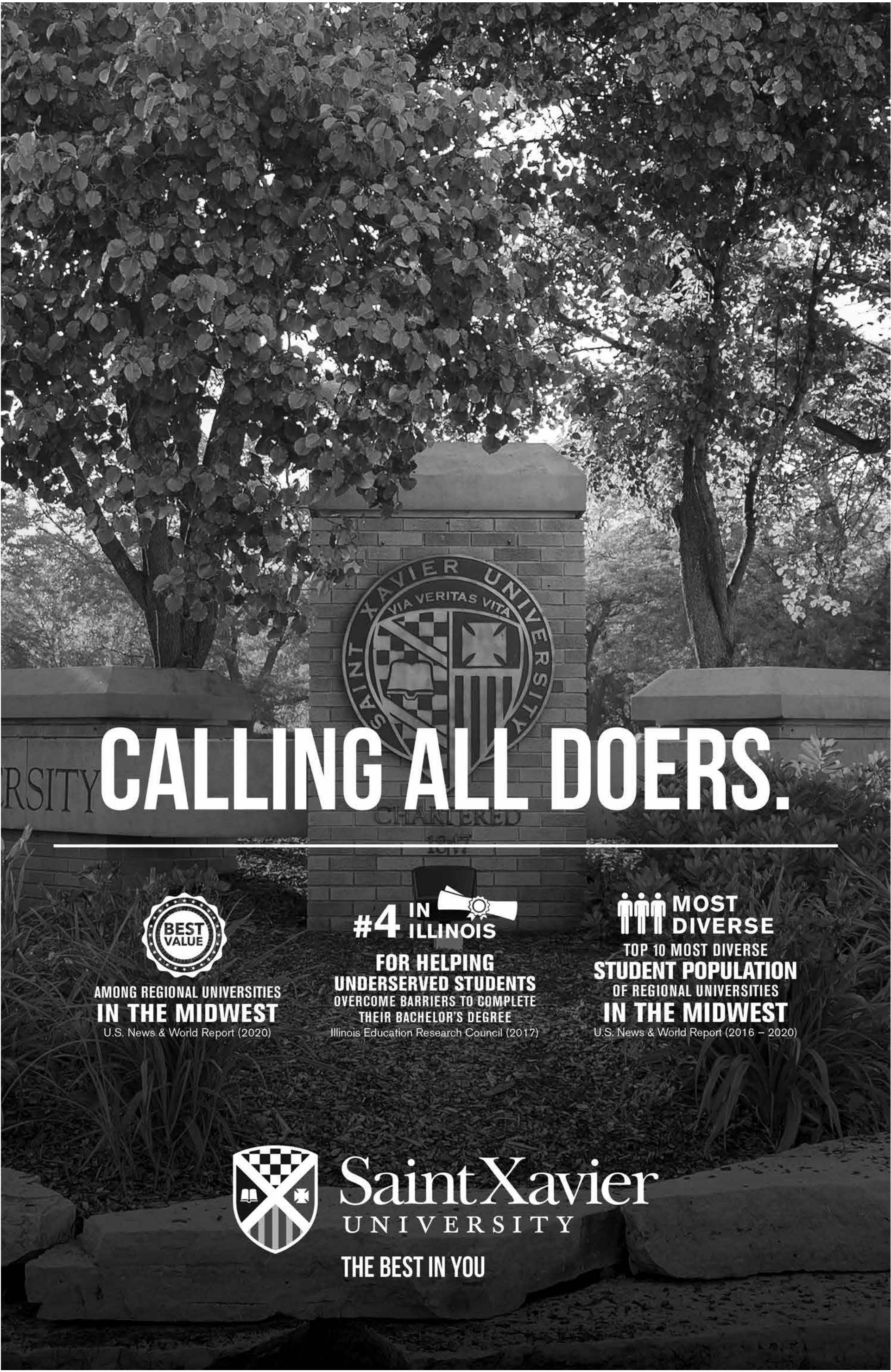
families are so grateful that their loved one doesn't have to leave but can transition to that wing of compassionate care that is the Johanson Wing."

The three-story expansion will provide state-of-the-art therapy rooms on the first floor and dining rooms on the second and third floors.

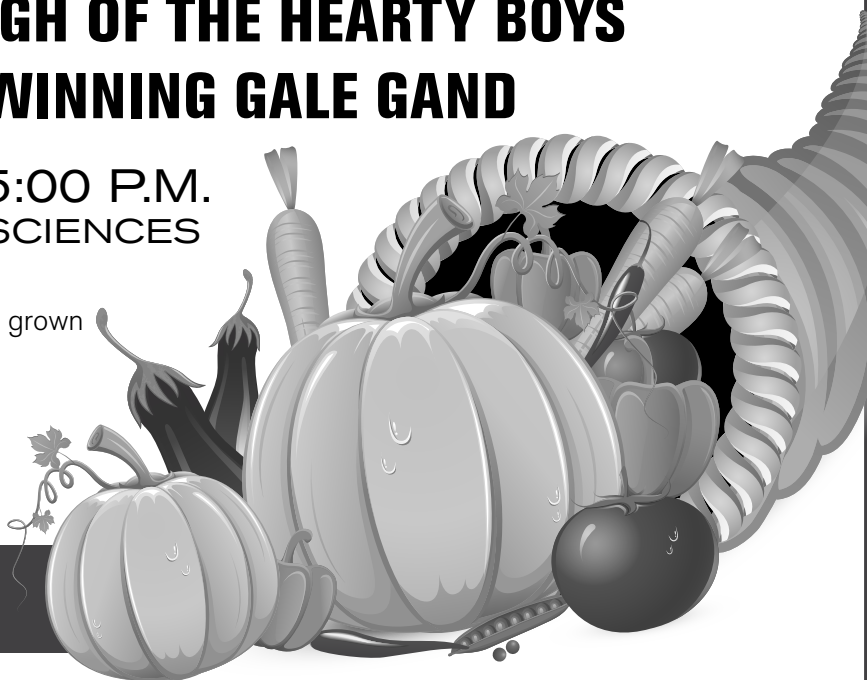

This will not be the same as previous start times of 12:01 a.m. Applications will be taken on a first-come, first-served basis. The number of participants is based on availability of funds. The program typically reaches capacity quickly. In previous years, the Shared Cost Sidewalk Program has closed in as little as 12 hours.

If you are interested in having any or all of your sidewalk replaced, call 311 or through the City's service request website 311.chicago.gov. Please note, any applications or requests made previously will not be fulfilled.

If you want to take advantage of the City's Shared Cost Sidewalk Program, this is the **ONLY** opportunity to sign up this year. Residents **MUST** use one of these two methods to apply; applications **CAN NOT** be processed by the 19th Ward Office.

Rep. Slaughter Hosts Town Hall Meeting

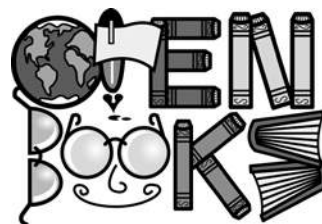
passed in Springfield and answer any questions that local residents may have."

Hurley, Cunningham bill to delay “aging out” of special needs students

Thanks to a cruel technicality in state law, there is nothing “happy” about the 22nd birthday of special needs students in Illinois. For them, their 22nd birthday is the date in which they “age out” of educational and vocational programs in the state’s public schools.

“It doesn’t matter if their birthday comes in the middle of the school year and they’re in the midst of a special program,” State Representative Fran Hurley said. “The day their 22nd birthday comes is the day they are unceremoniously kicked out of school. What should be a day of celebration is often one of the saddest days of their lives — a day they have to say goodbye to their friends and leave the security of a program that has helped them thrive.”

Hurley and State Senator Bill Cunningham have filed legislation to change the law and allow special needs students to remain in education programs for the entirety of the school year in which they turn 22-years old, which will allow young people with developmental disabilities to complete instruction and ease their transition into post-school life.

“The current law places an unfair burden on special needs students and their parents,” Cunningham said. “It’s hard enough to find a job or day programs for young adults with developmental chal-

lenges, but it is made all the more difficult in the middle of the school year when programs have already been filled with participants.”

Under federal law, school districts must offer services to any qualifying special needs student who is 21-years old or younger. As such, students from dozens of 19th Ward families are enrolled in CPS programs at South Side Occupational Academy and the Chicago High School for Agricultural Sciences, which has a cluster program for special needs students. The Illinois School Code for special education was written to conform to federal regulations, so it only requires local school districts to keep qualifying students enrolled until their 22nd birthday.

Joshua Long, the principal of South Side Occupational, and Ag School Principal Bill Hook, both support changing the state law to enable their students to remain enrolled through the entire school year after they turn 22-years old.

The legislation proposed by Representative Hurley and Senator Cunningham (House Bill 3897 and Senate Bill 2281,) has been endorsed by Illinois’ First Lady, M.K. Pritzker, who recently toured South Side Occupational Academy, where she discussed the “aging out” problem with school staff and 19th Ward Alderman Matt O’Shea.

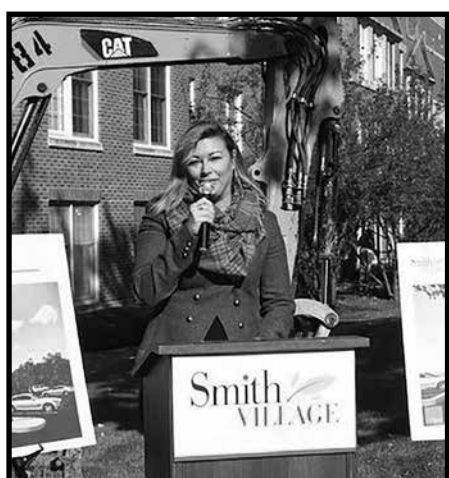

"We started conducting research in 2017 to ascertain the best way to update the Johanson Wing which was built in 1991," said McGee. "Based on our findings that larger, private accommodations were essential, we secured approval from the Illinois Health Facilities and Services Review Board to proceed with our modernization plan."

Like other speakers appearing at the groundbreaking, McGee's parents, Phil and Noreen McGee, reside at Smith Village. Noreen stood among the group of 30-plus well-wishers gathered on the southeast corner of the Smith Village campus.

Alderman Matt O'Shea expressed support and congratulations, after greeting his father, Dan O'Shea, and his father's dog, Ace, both residents of Smith Village. "This is more than a \$22 million reinvestment in our city," O'Shea said. "It's a much-needed way to keep families together in our neighborhood and exactly what the market expects."

Cook County Commissioner John P. Daley also commended Smith Village and the Smith Senior Living and Smith Village trustees for their commitment to expand common areas and to quadruple the number of private suites and rooms in the Johanson Wing. "Let me congratulate you," he said, adding that several close friends and family members have relied on Smith Village. "You care for people often at a vulnerable stage of their lives and provide such great support for their families."

Smith Village executive director Marti Jatis, welcomed dignitaries, members of the development and construction team, and guests. In her opening comments, she spotlighted the *US News & World Report* ranking that includes Smith Village among Chicago's top 19 skilled nursing care providers. Jatis' mother, Marianne, also resides at Smith Village.

The Johanson Wing was named

in 2002 for Gary Johanson, who had served for 22 years as executive director of the Washington & Jane Smith Home, the previous name for Smith Village.

After site preparation, construction is slated to begin its first phase at the south end of the wing in November. Spring of 2022 is the anticipated completion date of this

multi-phase construction project because the Johanson Wing will continue to serve short-term stay and rehab residents. The development and construction team for the project includes RLPS Architects, Weis Builders, Kimley Horn Engineers, Merlino Design Partnership, Inc. and Eventus Strategic Partners, LLC.

19th Ward Seeks Election Judges

The Chicago Board of Elections is seeking individuals to serve as election judges for the Municipal Election on Tuesday, March 17, 2020. Election judges administer election procedures in polling places and ensure that voters' rights are protected and respected on Election Day. Election judges receive pay for their services. Election judges are the officials responsible for the conduct of the election in the polling place. Responsibilities include opening the polling place and setting up the voting equipment by 5:00 am on Election Day; conducting a fair, impartial and secure election in the polling place; and tabulating the vote totals for the precinct and transmitting the results to Election central after the polls close at 7:00 pm.

"Election judges serve an important role in our democratic process, by ensuring an unbiased and uncompromised voting location," said Alderman O'Shea. "Being an Election Judge is a great way for people to not only meet residents of their community, but also take an active role in the election process."

- Among the requirements to become a Judge of Election, individuals must:
- Be a registered voter in Cook County (U.S. citizens at least 18 years of age);
 - Be able to speak, read and write English;
 - Be able to perform basic math;
 - Be of good understanding and capable;
 - Not be a committeeman, precinct captain or candidate and must agree not to serve as a judge if they become one;
 - Notify the Board of Elections if a person who shares his or her residence becomes a candidate, and must not serve as a judge in that election in any precinct where that candidate is on the ballot;
 - Be of good repute and character and not a registered sex offender anywhere in the United States and not have committed a crime that would require registering as a sex offender anywhere in the United States;
 - Agree that if the judge applicant is removed as an election judge due to misbehavior, neglect of duty or other cause, the person will not be paid for training or election day service;
 - Agree that if a person fails to perform all of the services required of a judge, the compensation may be reduced accordingly;
 - Agree that by law, the name, address and party affiliation are subject to public disclosure; and,
 - Agree that the Board of Elections may use any personal data provided in the Judge Application for the Board's internal operations.
 - Election judges who have completed training are paid \$200 for their service. For more information on being an Election Judge, please visit www.chicagoelections.com.

Dear Neighbor:

During the 2019 Legislative Session, we voted to pass an infrastructure plan that will provide almost \$3 billion dollars of much-needed funding to the Regional Transit Authority. It was our intention for this investment to increase access to affordable transit options for all residents of the Chicagoland area.

While overall Metra ridership has increased over the past 15 years, the Metra Electric and Rock Island lines have lost a third of their total ridership due to higher ticket costs and infrequent train schedules. Families in southwest side neighborhoods and suburbs are instead forced to endure long commutes with multiple transfers to access jobs and educational opportunities.

Cook County Board President Toni Preckwinkle’s proposed pilot program to cut the cost of tickets for riders at stations in Chicago and increase service on the Metra Electric and Rock Island lines would put our region on a long-term path toward sustainable, affordable transit options for all residents.


Riders in Chicago neighborhoods would see fares cut in half for a one-way trip to \$2.50, matching the Chicago Transit Authority’s fare. This has the potential to save current Metra commuters close to \$1,000 per year. Chicagoans who currently choose to drive, use ride hailing services or who rely on bus transit options that are often time-consuming and inconvenient would finally have the kind of efficient, affordable transit options that all Chicago residents deserve regardless of what neighborhood they live in. Commuters from suburban communities would also receive fare reductions and be able to take advantage of the more frequent Metra service that is included in the proposed plan.


This pilot program has the potential to increase Metra ridership in the communities that we represent by over 80,000 daily riders. While there are understandable concerns regarding how this might impact the CTA’s bottom line, we must look past the numbers and prioritize the people in our communities who rely on public transit. Through collaboration between the county, city and our transit agencies, those dollars can be recovered. However, the hours upon hours that parents spend commuting instead of with their kids, or college students are crammed onto buses rather than studying, cannot.


This unprecedented collaboration between the Metra, Chicago Transit Authority and PACE would create a model for future improvements across the region while providing affordable options that commuters in our districts need now.

The Chicagoland region is at its best when all of our residents are connected. We urge President Preckwinkle, Mayor Lori Lightfoot and our transit agencies to collaborate and implement this proposed pilot program.

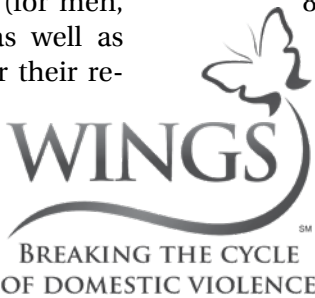

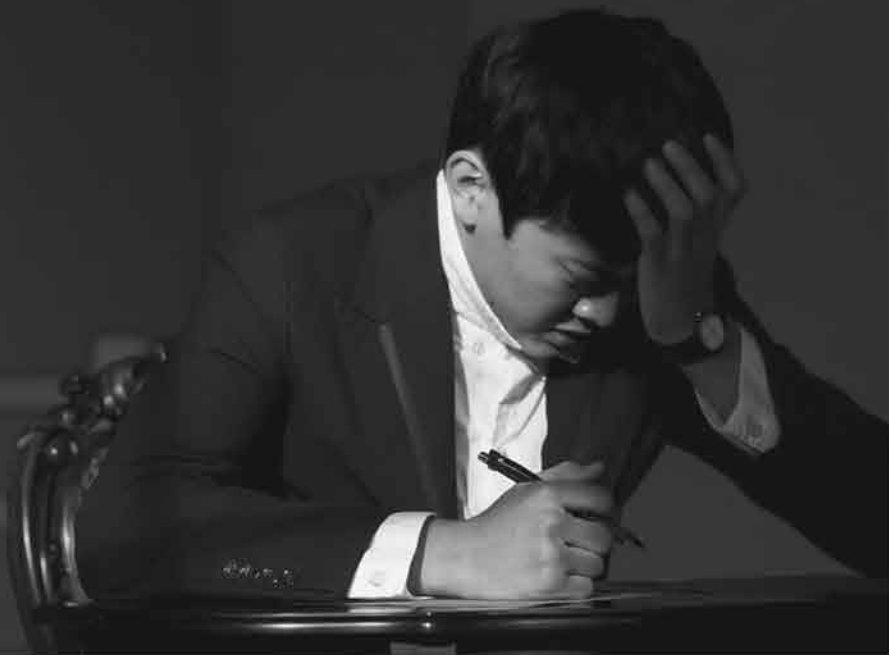
