
111th St. Streetscape \$7.9 million investment in Mt. Greenwood Corridor


This Spring, the Chicago Department of Transportation (CDOT) will break ground on a Streetscape improvement project on 111th Street from Homan Ave. (3400 W) to Sacramento Avenue (3000W). This project will extend the benefits of the previously completed Streetscape project on 111th Street from Central Park to Homan Ave. Through this project, 111th Street will be renovated with infrastructure upgrades and other decorative elements designed to make the area more pedestrian and business friendly. The project will include:



on February 27th, March 6th, March 13th, and March 20th. Yoga can help individuals decrease stress and increase their ability to focus and problem solve. First responders experience stress and




class and learn techniques to decompress. First responders and their adult family members are welcome to attend. Please bring a yoga mat and wear comfortable clothing.

O'Shea Ordinance **Protects Paramedics, Emergency Workers**

The Chicago City Council recently passed Alderman Matt O'Shea's ordinance to create new city fines and jail time for anyone assaulting a paramedic or other emergency workers. Under

O'Shea's ordinance, assault on an emergency worker is a violation of city code punishable by up to six months in jail with fines up to \$1,000.

The ordinance comes in response to several recent attacks on first responders in Chicago. Most recently, a brick was thrown

through the window of a Chicago Fire Department Ambulance as they responded to a call. In October of 2021, Chicago Fire Department Paramedic-in-Charge Matt Clohessy was beaten by a patient exiting his ambulance, after he was found on the street possibly suffering an overdose. The patient struck Clohessy with a metal lock he had concealed on his person. A photo of Clohessy's injuries is available on Chicago Fire Department Firefighters Union Local 2's Facebook page. He suffered a deep laceration under his left eye and his eye was

swollen shut, but he was fortunate that he only required stitches and was treated and released.

"It is of the utmost importance that we protect the men and women on our front lines, so they can

> safely provide care in an emergency situation," said O'Shea. "It is my hope that this ordinance will be the first step in curbing the increase in violence that Chicago paramedics and emergency workers have been dealing with."


paramedics put their lives on the line every time they respond to a call. They are exposed to gunshots and fights taking place outside their ambulance and assaults from patients they are treating," said Firefighter and Local 2 Public Relations Director Pat Quane. "This City Council ordinance is a small step toward protecting first responders who rush to dangerous situations, unarmed and simply trying to save the lives of victims of violence, accidents and drug overdoses on the streets of Chicago."

Seniors will learn how to protect themselves from crime; communicate with law enforcement; guard against con games and scams; and understand the functions of the Cook County Jail and Courts by participating in the Senior Citizen Law Enforcement Academy. Participants, who attend all six sessions, will be honored at a graduation ceremony and reception on Tuesday, May 16.

"With threats against older adults on the rise, even the savviest residents can benefit from information from experts at the Cook County Sheriff's Office," O'Shea explains.

Smith Village will host the se-

ries of sessions. "We are honored to be a part of this important program," says Smith Village executive director Marti Jatis. "Smith Village is committed to doing our part to improve the health and safety of the community and the Senior Citizen Law Enforcement Academy offers terrific tools that older adults can put to use."

Cunningham supports new law to claw back SAFE-T Act provisions

State Senator Bill Cunningham voted to approve a series of changes to the Illinois SAFE-T Act during the closing days of the 102nd General Assembly, including provisions that will make it easier for police to enforce trespassing laws and track down offenders who attempt to escape electronic monitoring.

"I voted against the SAFE-T Act when it passed two years ago and I have been working with law enforcement ever since to amend the law," said Cunningham. "These latest changes make the law more workable for officers on the street and will make residents of Illinois safer."

The new legislation, House Bill 1095, was passed during this fall's Veto Session. It addresses many of the concern law enforcement officials have raised about the SAFE-T Act, which was initially voted into law in January 2021. The new law clarifies that judges can issue an arrest warrant or summons when a suspect misses a court date and can hold those accused of forcible felonies in jail while their cases are pending. It also explicitly authorizes the police to detain any person who poses a threat to the community - including trespassers. The original text of the SAFE-T Act raised concerns among police agencies that they would only be able to issue tickets to individuals found trespassing on private property and would not be allowed to physically remove them. The new

legislation places specific language in the law ensuring police can arrest and remove trespassers.

Additionally, HB 1095 ensures law enforcement can immediately charge electronic monitoring suspects who willfully flee with escape, instead of waiting 48 hours as the original law required.

"The SAFE-T Act essentially gave electronic monitoring detainees a two-day head start to flee police if they decided to escape from house arrests," Cunningham said. "The new law makes it clear that when an electronic monitoring offender willfully flees, he can be arrested and jailed immediately and


charged with escape."

Another part of the SAFE-T Act that would have eliminated the use of cash bail has been temporarily held up in state court. Scheduled to go into effect January 1st, 2023, the


Pre-trial Fairness Act would have prevented judges in Illinois from setting cash bail for suspects who appear before them in bond hearings. Under the new law, judges would have to decide to either detain a suspect in jail while their case was pending or release them on their own recog-

nizance. Critics of the law have argued that eliminating cash bail will result in the release of more suspect and jeopardize public safety. But a judge in Kankakee County found the law was unconstitutional, delaying its implementation. That lower court decision is pending on appeal before the Illinois Supreme Court, which is expected to take

up the case in March. Until the Supreme Court rules, judges will still be able to set cash bail.









O'Shea Challenges Students to take the Polar Plunge for Special Olympics

Registration for the 23rd Annual Chicago Polar Plunge, presented by Jackson, which is the largest Polar Plunge event in the Midwest, and benefits the athletes of the Special Olympics Chicago/Special Children's Charities (SOC/SCC) program, is now available by visiting www.chicagopolarplunge.org A virtual option is also available. This year, Alderman O'Shea is challenging students throughout the 19th Ward to create school based teams and take the plunge to support Special Olympics programming in schools and parks throughout the City. Students are provided a reduced \$100 fundraising minimum to plunge and teams of 20 or more are eligible for free bus transportation.

The Chicago Polar Plunge has become the must-attend winter event in the city. The 2022 Chicago Polar Plunge raised over \$1.8 million dollars for the athletes of SOC/SCC, with over 3600 plungers and 350 teams participating. Unlike other plunges in the State of Illinois, all money raised from the Chicago Polar Plunge stays within the city of Chicago to benefit the athletes of the SOC/SCC program who live in the city.

Registrants are asked to raise a minimum of \$200. All participating

plungers will receive free parking at Lincoln Park Zoo, or a free bus for groups of 20 or more; a souvenir t-shirt; towel when exiting the water; and free photo downloads.

For more than a decade, the Chicago Polar Plunge has become one of the largest, and most wellknown plunges in the country, attracting celebrity plungers, and garnering national and international attention. Plungers have included "The Tonight Show" host Jimmy Fallon, actors Vince Vaughn and Dax Shepard, musician/artist Lady Gaga, the casts of Chicago Fire, Chicago PD, and Chicago Med, Al Roker, Craig Melman, and other personalities from The TODAY Show. Last year, celebrity plungers included Chris Witaske, co-star of Hulu's *The Bear*, and also known as the Chicago Party Aunt,

Mayor Lori Lightfoot, and First Lady Amy Eshleman.

The Chicago Polar Plunge is an enormously important event for Special Olympics Chicago, as it helps to fund the year-round activities and events enjoyed by thousands of athletes throughout the city. Funds raised from the Chicago Polar Plunge help to pay for transportation to competitions, uniforms,

sports equipment, and more, for the Special Olympics Chicago programs and athletes.

Online registration will remain open until Saturday, March 4th, and walk-up registration is available the day of the event.

Athletes compete and train in 17 sports throughout the year in

Chicago Public Schools and Chicago Park District locations.

In addition to sports activities, SOC/SCC provides extracurricular activities including arts programming, an athlete produced cable access television show, cooking nights, dance parties, special events, field trips and more.

2023 Get Behind the Vest Events Planned

19th Ward Alderman Matt O'Shea's annual Get Behind the Vest Pancake Breakfast will be held on Sunday, February 19th, 8:00am - 12:00pm at Saint John Fisher School, located at 10200 S. Washtenaw Ave. For the first time since 2020, the Get Behind the Vest Pancake Breakfast will be dine-in and in-person. Now in its ninth year, Ald. O'Shea's Get Behind the Vest Pancake Breakfast benefits the Chicago Police Memorial Foundation's (CPMF) initiative, which purchases bullet proof vests for Chicago Police officers.

The morning will kick-off with a mass for police officers, their families, and supporters, at 8:00am at Saint John Fisher Church.

Admission to the Pancake Breakfast is \$5 per person or \$25 for families, which includes all you can eat Original Pancake House (Beverly) pancakes and sausage.

In addition to the Get Behind the Vest Pancake Breakfast, a number of events will be hosted to raise additional funds for the CPMF. For the second year, WGN Radio's Sweet Home Chicago with David Hochberg has partnered with Ald. O'Shea for a "Vest-a-Thon" Fundraiser, which will take place on Saturday, February 18th. The 2022 Vest-A-Thon raised over \$200,000 for the purchase of bullet proof vests. The Vest-a-Thon will feature stories of officers whose lives have been impacted by bullet proof vests, including brave officers from the Chicago Police Department, who will share their perspective on the increasingly difficult work they

do each day. Donors to the Vest-A-Thon will have the opportunity to win incredible prizes including skybox experiences at many of Chicago's best teams, sports paraphernalia, and much more.

"Chicago Police officers are on the front lines every day to ensure our safety, and it is important that we do what we can to insure they get home safely to their families at the end of each shift," said Ald. O'Shea. "In 2014, Chicago Police officers were shot at a total of eight times, and none were struck by gunfire. Compare that to 2021, where 69 officers were shot at, 10 were struck by gunfire, and one was fatally shot. In 2022, Chicago Police officers were shot at 48 times, and eight were struck by gunfire. It is imperative that Chicago Police Officers have access to up-to-date bullet proof vests with the latest technology advancements, and the funds raised through the Get Behind The Vest Pancake Breakfast and Vest-A-Thon will help to provide that."

In the past nine years, Ald. O'Shea's efforts have raised more than \$500,000 to support the Chicago Police Memorial Foundation's initiative. Bullet proof vests need to be replaced every five years, at a cost of about \$600 each. To date, CPMF has replaced more than 11,000 vests, with an annual goal to replace 500 vests for officers each year.

Ald. O'Shea sits on the Chicago Police Memorial Foundation Advisory Board and the Chicago Police Chaplains Ministry Board of Directors. He represents the communities of Beverly, Morgan Park and Mount Greenwood, where thousands of first responders reside.

The Get Behind the Vest Pancake Breakfast is generously cohosted by Saint John Fisher Parish, the Harrigan Family and the Original Pancake House (Beverly).

Mercy Circle resident shares memories of St. Xavier and Mother McAuley's early days

Change and challenge were in the air in 1952 when the Sisters of Mercy made the bold move to purchase 155 acres of land between 103rd and 99th Streets from Central Park to Pulaski Avenues. There, they would relocate Saint Xavier College from its home since 1901 at 49th Street and Cottage Grove Avenue.

Sister Mary Ann Bergfeld, RSM, now a Mercy Circle resident, recalls what it took to follow the post-World War II tide of young Catholic couples with large families moving to the far southwest side. They needed schools.

So faithful to their commitment as educators, Sisters of Mercy established Mother McAuley High School on the north side of the 155 acres. They also invited the Irish Christian Brothers to build a boys' high school on the northwest parcel of their land.

When she was a freshman at Saint Xavier College at 49th and Cottage Grove, Sister Mary Ann recalls one of many roles too numerous to count that young Sisters played in managing such a major move

"Soon the library had to be boxed up for transfer to the new location. One young Sister, a member of the Miller family, asked her family to provide sturdy beer cartons. Once the library was boxed, all of us young Sisters got on a bus and headed to the new campus to

"As our students and their families from those early days have aged, so did the Sisters who have served our neighbors for close to 70 years. Me among them," says

unpack them so the new campus would be ready to welcome students in 1956," she says.

"Before too long, I advanced from library mover to teacher at what has become Saint Xavier University," says Sister Mary Ann, who was a professor there for 38 years. Sister Mary Ann. When she was ready to retire she wanted to stay in the neighborhood she had called home for decades. Again, Sisters of Mercy had the foresight to plan ahead. "In 2013, I was one of the first residents to move into Mercy Circle designed and staffed to meet seniors' needs," Sister Mary Ann says. "Today, I love my apartment, my companions from the neighborhood and those from afar! I feel the plans of long-ago Sisters of Mercy, and my life, now have come full circle." 

and loving the food in the dining room," says Hudec. "She feels confident knowing she has a call button to click for help whenever she needs someone."


